



ANNUAL MEMBERSHIP MEETING

Maria Lane Arends opened the meeting at 11 AM and introduced Julianne Smith, VP of Education, who welcomed everyone to the first general meeting of The League Club on Zoom. Julianne reviewed the basics of Zoom to those who were online and emphasized patience as we are all learning new technology.

**APRIL 2020 ANNUAL MEMBERSHIP MEETING MINUTES:**

President Gigi Stewart began by reviewing the year. Although some events were cancelled, many milestones were accomplished:

- Donated \$10,000 to Meals of Hope from the Emergency Trust Fund to feed the needy.
- Welcomed the second Naples Tables, "Celebrate 2020 with Panache".
- Enjoyed many social gatherings such as the summer luncheon, Black & White and Thursday Night and Welcome Back parties.
- Membership meetings with record attendance were held with varied topics including Social Media Savvy, Health and Wellness, and the Songs of the Seasons.
- Volunteered our time at Empty Bowls, Meals of Hope, Valerie's House Gulf Shore Players and others.
- Welcomed 41 new members and now the membership stands at 623.
- The Endowment Fund grew to \$218,500.
- Updated our technology and continue to do so.
- Continue to have the support of the minor League under the Presidency of Bob Gester.

Gigi thanked her Board and stated there were four motions to approve.

The Finance Committee proposes the total operating budget for 2020/2021 to be \$107,650 based on membership of 610 members.

**MOTION: I move to approve a change of grant funds for agencies to unrestricted.**

This was a recommendation by CIC and approved by the Executive Committee under the Governor's Emergency Act due to the Covid pandemic.

The motion was approved unanimously.

Last year's Nominating Committee presented a slate of officers for the 2020/2021 to the Board of Directors at the February meeting. The slate of Officers has been presented to the membership in the Newsletter and several EBlasts.

**Community Involvement Committee** - Connie Mockenhaupt

Last June, invitations were sent to 112 non-profits in Collier and Lee counties. 65 agencies submitted Letters of Intent (LOI). A screening committee reviewed the LOI’s and voted on asking 25 agencies to submit a formal proposal. All 25 proposal have been received. On December 3, the committee will begin its challenging work to review the proposals. All site visits will be held virtually. Thanks to many, TLC will distribute up to \$355,000 to fund projects that will provide education, food, health care and shelter to the underserved woman, children and elderly in Collier and Lee counties.
